Below, we have explained how your data (that you provided upon registration to Corinium Players) is used and shared and ask that you take a moment to read through it. This information is gathered to assist in the smooth running of the group and enables us to communicate with you. ## Why do we need your data?

We need to collect and store some of your details, for example your name and email address, so that we can let you know about things like rehearsal and event dates, subscription payments, and social events.

## What data do we collect from members?

We collect <u>some</u> of the following types of data from members (we don't collect *all* of this data on *all* members – we only collect it if it's needed):

Name	Gift Aid declarations
Email address	Bank details
<ul> <li>Postal address</li> </ul>	Medical information
Phone number	Age /DOB
<ul> <li>Emergency contact details</li> </ul>	Gender
Photos/video footage	Criminal records check
Subscription payments	Passport Number

We check what data we have on members every two years and remove it if we no longer need it. If you leave the group, we'll make sure we stop using and/or delete any data we don't need to keep (e.g. for financial reporting). If you wish to stay informed of future group reunions after leaving Corinium Players, we will give you the option to do so at that time.

### What do we use it for?

Any of the information listed above might be needed to manage your membership with Corinium Players and to organise and run our activities. We won't ever use this data for anything else unless you give us your active consent for that additional use.

*If* you give us your consent, Corinium Players will add your email to our mailing list for the group's marketing/promotional communications. We will always include opt-out options on all such communications. You can withdraw your consent at any point by contacting the membership secretary (mariepshipley@gmail.com).
